What personal data we collect and why we collect it.

Comments.

When visitors leave comments on our site we collect the data shown in the comments form, and also the visitor's IP address and browser user agent string to help spam detection.

Contact Forms.

The contact form provided is an efficient way for visitors to send enquiries to W S C L Limited. We understand that you trust us with your personal information and we are committed to ensuring you can manage the privacy and security of your personal information yourself. The data you provide is purely used for our own customer services purposes. We do not use your information for marketing purposes and only retain your information until all necessary correspondence between us is concluded. The form is securely submitted via a private email gateway on our web host's private servers.

Cookies.

Cookies are small files saved to the user's computer's hard drive that track, save and store information about the user's interactions and usage of the website. This allows the website, through its server to provide the users with a tailored experience within this website.

If you leave a comment on our site you may opt-in to saving your name, email address and website in cookies. These are for your convenience so that you do not have to fill in your details again when you leave another comment. These cookies will last for one year.

If you have an account and you log in to this site, we will set a temporary cookie to determine if your browser accepts cookies. This cookie contains no personal data and is discarded when you close your browser. Currently there are no user account facilities on our website.

When you log in, we will also set up several cookies to save your login information and your screen display choices. Login cookies last for two days, and screen options cookies last for a year. If you select "Remember Me", your login will persist for two weeks. If you log out of your account, the login cookies will be removed. **Please note:** Currently user log in is not enabled on our website.

If you edit or publish an article, an additional cookie will be saved in your browser. This cookie includes no personal data and simply indicates the post ID of the article you just edited. It expires after 1 day. **Please note:** Currently the ability to edit or publish articles is disabled on our website.

Embedded content from other websites.

Who we share your data with.

Analytics

This website uses tracking software to monitor its visitors to enable us to better understand how they use it. This software is provided by Google Analytics which uses cookies to track visitor usage. Personally Identifiable Information (PII)

The Google Analytics Terms of Service, which all Google Analytics customers must adhere to, prohibits sending personally identifiable information (PII) to them. This is a policy that we expressly agree and comply with.

Anonymising IP Addresses

For your privacy and protection, our website analytics settings are set to anonymise a visitor's IP address. This means that Google Analytics will substitute the final 3 digits of any visitor's IP address with '000' so that it cannot be tracked to an accurate location. Google Analytics will be able to establish a country and perhaps a region of origin, but won't be able to isolate a more detailed location such as a specific town, city or street. Our website settings also instruct Google Analytics to refrain from tracking visitors who include a 'Do Not Track' header when browsing our site.

How long we retain your data.

For users that register on our website (if any), we also store the personal information they provide in their user profile. What rights you have over your data.
